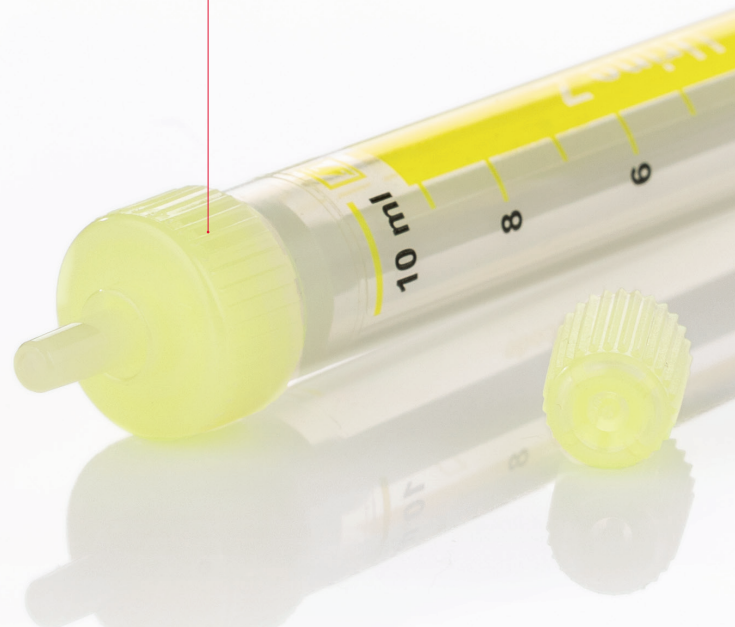

The Urine-Monovette® enables hygienic urine collection and is also suitable as a primary tube for test strips and analysers and as a centrifuge tube for collecting sediment

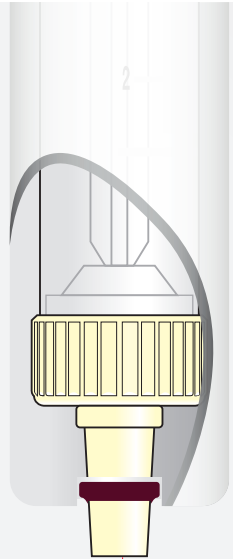


New

A needle is no longer needed with the new needle-free collection function. The Urine-Monovette® easily pierces the innovative NFT membrane.

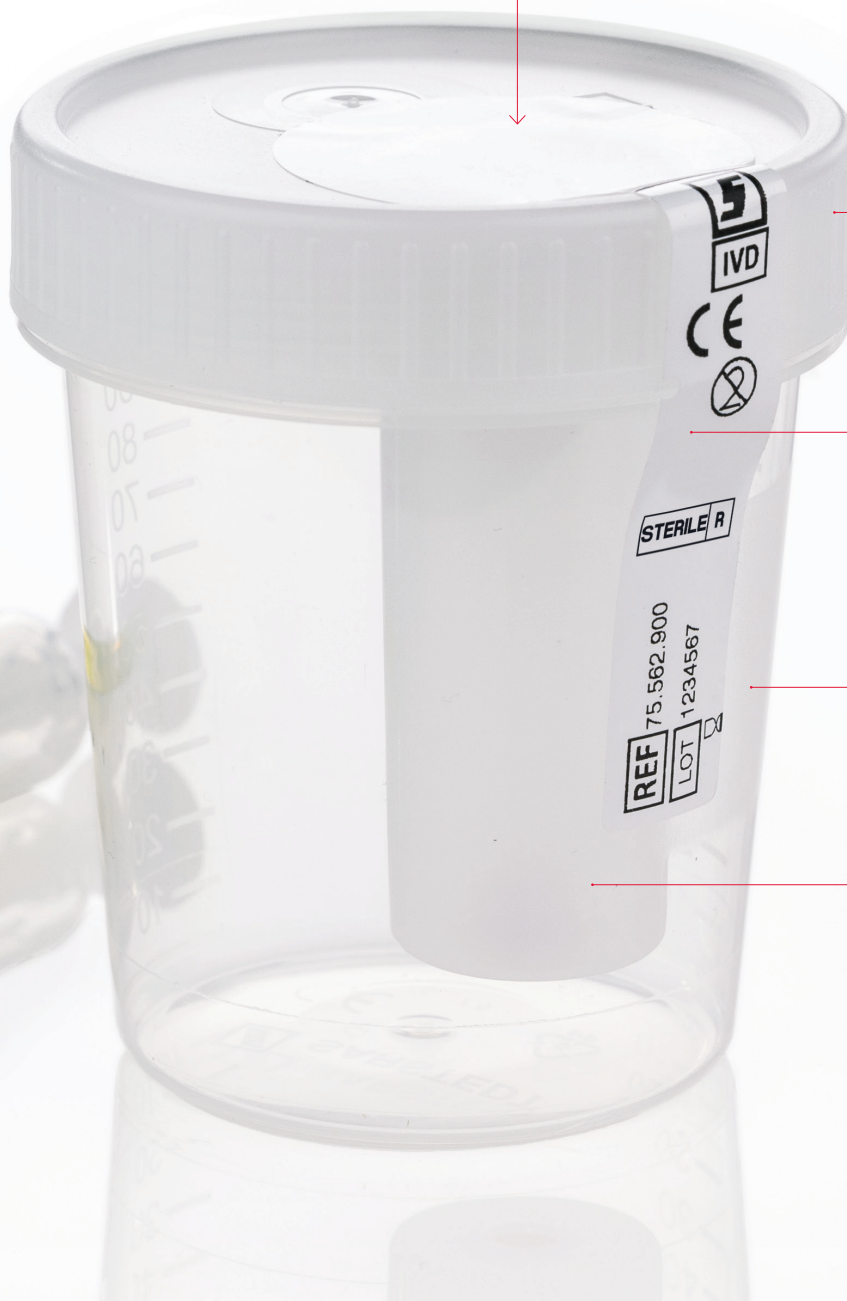
Following an easy collection, the opening is immediately closed and hygienically sealed even after collecting several samples.

The NFT system with Urine-Monovette[®], NFT urine cup and NFT urine container ensures hygienic working conditions during the entire sample collection process:

- With the Urine-Monovette[®] and the enclosed suction tip, you can carry out the transfer process without a needle, even if the filling volume is very small. A separate transfer device as in vacuum systems is not needed.
- Extensive training is not required.
- With the Urine-Monovette[®], the aspiration principle allows the collection process to be repeated if necessary – there is no risk of loss of function through repeated use.
- The well-designed, needle-free collection function minimises the risk of injury for staff and patient.
- After collection, the products of the NFT system do not need to be disposed of separately in needle-proof containers – saving time and money compared with products with an integrated needle.

The NFT urine container with a volume of 3,000 ml, ergonomic grip, large opening diameter and transparent inspection window with graduated scale in increments of 100 ml

- The Urine-Monovette® enables hygienic, needle-free sample collection from urine containers or urine drainage systems.
- A urine analysis with commercially available test strips can be carried out directly in the filled Urine-Monovette®.
- The Urine-Monovette® is suitable for transporting and shipping according to the P650 packaging instructions of the ADR and IATA. It can be used in centrifuges and analysers for collecting sediment.

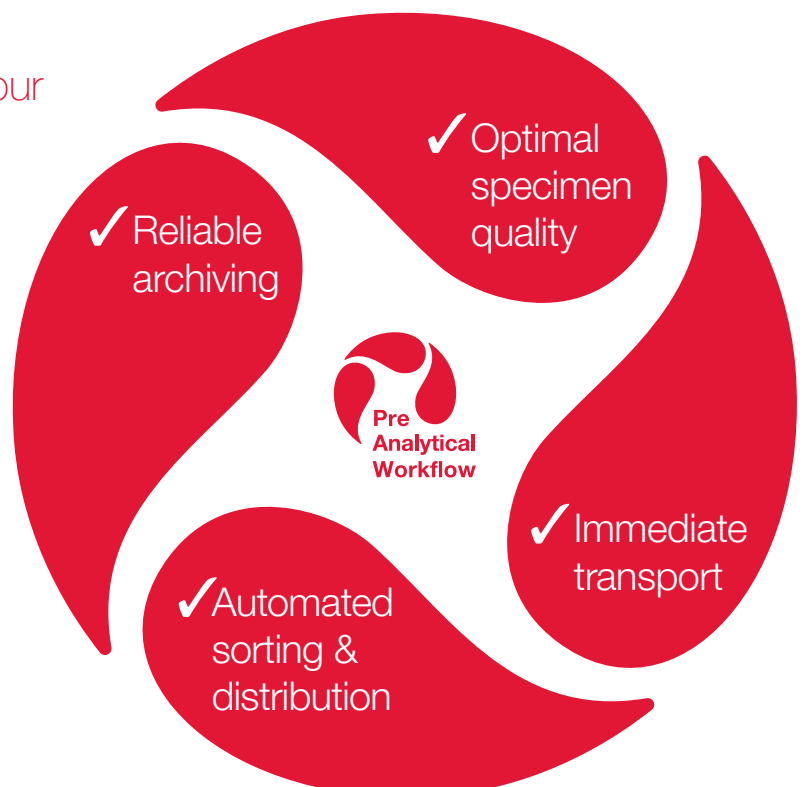
